RE: Tender Clarifications

Please find below the response for the queries from the bidders for this tender in **RED**

- 1.) Does LTA need a separate alarm system or solution with CCTV and we put a virtual fence so that if somebody crosses that fence the alarm which are attached with NVR will be enabled automatically. **Separate Alarm System which goes off when the sensor detects movement that is near the doors and safe or the doors that are forced to open. CCTV to be separate from Alarm System.**
- 2.) Does LTA want separate set up in every office with NVR and screen for monitoring or we only install cameras in every office, which are then connected through fiber optic with the main server at LTA HQ where you can monitor all the offices. **Separate set up in every office with NVR that should be accessed at HQ.**
- 3.) Requesting site survey.
All LTA Offices (Fiji Wide) is aware of the site inspection, bidders can visit the Branch and meet with the Branch Manager or the Team Leader.
- 4.) Floor plans for all these sites.
The Authority request the bidder to physically inspect the locations with the assistance of Branch Manager or the Team Leader.
- 5.) Do you have a marked plan for positioning of the camera's, if yes can you please share, if not can you please use your fire exist plan and provide us one?
The Authority request the bidder to physically inspect the locations and advice should if the current cameras listed in the TOR are sufficient.



6.) Do you have places or location within the premises that will require Wireless Bridge?

7.) Do you have space allocated for NVR, cables, etc. or do you need to have a rack for each site?

The bidder to inspect and propose if the rack is required. If so, bidder is to clearly mark the location and indicate for which office. Also include the cost for the rack in the proposal.

8.) For your monitoring center, do you require multiple TV's, joysticks, etc.

Kindly note that **Ministry of Defense, National Security & Policing** is responsible for the administration of the **Security Industry Act (2010)** which regulates the private security industry and Security services providers in Fiji including those companies who install, maintain, sell, repair or service by physical or electronic means any security equipment.

As stipulated in the **Security Industry Act 2010, Part 3 Section 13, 1 (a)**, "No person may employ or provide other persons to carry on any security activity unless that person - is the holder of a master license"

Hence, the Authority request the bidders to provide valid Security Master Licenses as this will be a mandatory requirement. Please note the Authority will not consider the submission should the valid Security Master Licenses is not provided.
