Application For Road Permit (Carrier Licence) Transfer/Re-Issue/Amendment

Land Transport Act 1998 [Section 65 [3] [c]

- Purpose:** A road permit issued which authorizes the use of motor vehicle licensed as a road service vehicle for the transportation of passengers and goods at separate fares on: -
- Stage Service:** A schedule service along a specified route between terminating points with stops intended to meet the needs of persons along or in the vicinity of that route or;
- Express Service:** A schedule service between terminating points with or without a limited number of stops at hotels or towns intended to meet the needs of the general public.
- Types of Vehicle:** An omnibus equipped for conveyance of not less than 16 persons excluding the driver and constructed so that the driver and passengers are located in the same structural compartment, which must be certified by a Certifying Officer.

REQUIREMENTS TO BE PROVIDED BY THE APPLICANT

- (i) Duly completed application forms in duplicate;
- (ii) The applicant's financial stability and a letter from the bank or a current bank statement;
If applicant possess a carrier a minimum balance of \$6050.00 to be shown, without a vehicle a balance of \$10,000.00 should be shown.
- (iii) Details of any business or association where any other permit was issued by the Authority;
- (iv) In case of the applicant being a limited liability Company Registration Certificate and Memorandum and Articles of Association to be provided.
